#### PURPOSE OF THE FOUNDATION

The Rollin M. Gerstacker Foundation was founded by Mrs. Eda U. Gerstacker in 1957, in memory of her husband. Its primary purpose is to carry on, indefinitely, financial aid to charities of all types supported by Mr. and Mrs. R. M. Gerstacker during their lifetimes. These charities are concentrated in the states of Michigan and Ohio.

# President's Letter

During the year just past the trustees saw fit to promote me to chairperson, so this will become my swan song as president of the Foundation. It hardly seems possible that I have been a trustee of the Foundation for 54 years now and its president for 36 of those years, but that is indeed the case.

The years have literally flown by, and now I look forward to my service in the new position of chairperson with eagerness.

As many of you know, Lisa J. Gerstacker became president of the Foundation at its annual meeting in December, 2011. I have worked closely with Lisa since she became a youthful trustee following her graduation from Midland High School in 1973, and I can attest that she is superbly qualified to serve as its chief executive. She has been closely involved and familiar with the detail of its activities for 39 years.

We look forward to a new era of achievement under her leadership.

During the year we memorialized our late and long-time administrative assistant by establishing the Mary F. McDonough Memorial Scholarship at the Midland Community Foundation. The scholarship will become active beginning in 2013.

Our grant-making was slightly up from last year at \$7.2 million, and we made a number of grants toward significant and innovative new projects. This included a grant to the MidMichigan Medical Center towards the building of a medical education building; a gift to the Meridian Public Schools for a 21st Century Learning Project; a gift toward the establishment of an early childhood and family research center in Midland; and a gift to Albion College for the renovation of its Stockwell Library and establishment of a Jack S. Ludington Career Internship Center in that library.

I am so grateful, more than I can express, for the help all of you have given us over the years towards the work of the foundation.
