

#### President's Letter



2016 was an exciting and strong year for the Rollin M. Gerstacker Foundation. Our trustees increased our annual giving to nearly \$8.8 million to many varied and worthy projects. Consistent with our mission and purpose, most of our grants were directed to local communities in the State of Michigan.

Certainly of great interest to the citizens of Midland is the renovation of the Midland County Courthouse. We are delighted to participate and work in partnership with several other Midland based foundations on this effort. Our contribution in the amount of \$1,500,000 will provide greater operating efficiencies to county government and re-open the doors of the Courthouse once again to Main Street. Hooray!!

We are also very pleased to provide funding in the amount of \$2,500,000 for a "face-lift" and structural enhancements to the Tridge. Since 1981, this icon and landmark has been a beacon for riverfront development in Midland. Work is scheduled to begin this Spring. Check out the progress!

In honor of our long time and valued trustee, Frank E. Gerace, we granted \$200,000 to Case Western Reserve University for a Concrete Laboratory in his name at the Case School of Engineering. This new commitment is in addition to a previous grant in the amount of \$300,000 to Case in honor of Frank. Frank Gerace was a much beloved business and community leader in Midland. Frank served with distinction as a Foundation trustee for over 20 years.

We at the Foundation continue with our commitment to aid and participate in further downtown and riverfront developments in Midland. We are optimistic about the future, and look forward to our continued involvement with Momentum Midland and the citizens of Midland to build a dynamic city of growth and vibrancy in the years ahead.

We also have accepted, with reluctance, the resignation of an outstanding trustee, Alexio R. Baum, son of Gretchen S. Schuette. Alexio is a talented individual and has been a valued trustee for 20 years. Alexio's business travels and work responsibilities have restricted his desired level of participation at the Foundation. Thank you, Alexio, for your service, kindness and love of Midland!

The Rollin M. Gerstacker Foundation is nearly 60 years young. Over the years, many tremendous family and community leaders have served as trustees and provided sound wisdom to many. As we look to the future, we are pleased to announce the election of the next generation of family leadership to the Board of Trustees. Newly elected trustees are: Laurie G. We are very pleased indeed to welcome these new family members to the Board of Trustees.
